All non-profit organizations that have a charitable purpose and do business in New Hampshire as public charities are required to register and file annual financial reports with the Charitable Trusts Division, pursuant to RSA 7:28.

On the enclosed *Certificate of Registration* you will find the registration number issued to your organization. Please refer to this number in all correspondence and telephone conversations with this office.

Your organization's annual financial report (form NHCT-2A or IRS Form 990 and the accompanying Annual Report Certificate and Appendix) will be due four and one-half months after your fiscal year ends. There is a \$75.00 statutory filing fee required with this report. Form NHCT-2A and an Annual Report Certificate will be mailed to your organization at the end of your fiscal year to the address you have given on the Application for Registration. **Please be sure to advise this office of any name or address change.** Instructions relative to the filing of this report will be attached to the form. Please be sure to read these instructions carefully.

The first report and filing fee that must be filed is for fiscal year ending  
12/31/03, due in this office on or before 5/15/2004.


